



Post Lottery Applications Have Significantly Increased



MSDC received significantly more applications from elementary aged, non-entry grade applicants (PK4, 1st-5th) living in Wards 3, 5, & 8 compared to both last year and pre-pandemic.



 - Analysis of outcomes of applicants applying in the lottery.

Data Sharing – Differentiating Approval Process

MSDC has established a formal data request process on the MSDC website. This process is for any external data requests of non-public applicant data and clearly outlines requirements and expectations.

Challenge

Present language does not provide a discretionary decision process for renewing, repeating, or frequent data requestors.

Goal

Differentiating the approval of data requests between first time applicants and renewing, repeating, or frequent data requestors will add efficiency and clarity to the data request process.



Data Sharing – Differentiating Approval Process

Current Policy Guide Language:

MSDC has established a formal data request process on the MSDC website. This process is for any external data requests of non-public applicant data and clearly outlines requirements and expectations.

Proposed Addition:

MSDC has established a formal data request process on the MSDC website. This process is for any external data requests of non-public applicant data and clearly outlines requirements and expectations. To ensure previously approved data requests can continue policy research to the betterment of residents of the District of Columbia and My School DC as a whole, the Common Lottery Board has delegated discretion to the Executive Director of My School DC to renew appropriate & previously approved data requests without an additional Board vote. The Board will be notified of all renewed requests made at the discretion of the Executive Director.

Internal Analysis – Clarifying Decision Maker

MSDC will share lottery data for internal deliberative purposes to inform policy decisions.

Challenge

The decision maker is not clearly specified, and the 'deliberative purpose' is both vague and too broad.

Goal

Specify the decision maker to improve efficiency of internal data requests.

Clarify the purpose to align with Common Lottery goals.

Internal Analysis – Clarifying Decision Maker

Current Policy Guide Language:

MSDC will share lottery data for internal deliberative purposes to inform policy decisions.

Proposed Addition:

MSDC may share lottery data with state education authorities that are inclusive of the DME, OSSE, and/or DCPCSB, for deliberative purposes to inform policy decisions that align with the goals of the Common Lottery. Approval of internal data requests rests within the discretion of the Executive Director of MSDC. The Board will be notified of any data requests approved at the discretion of the Executive Director.

Challenge

Public data presently omits the number of applicants that have applied to each grade, leaving the lottery story incomplete for D.C. families and applicants.

Goal

Publish the number of applicants who have applied to each school grade by the release of the lottery.

School-level data will include the number of applicants by the lottery deadline, lottery seats made available in the lottery, waitlist length on Results Day, and historic waitlist movement.

Data Request Vote







FutureEd has launched a comprehensive study of the District of Columbia's public high school system. To support their analysis, they are requesting application data to identify, describe, and publicly display applicant choices from middle to high school.

Key Data Elements Include:

- Who: 9th grade applicants only.
- When: SY17-18 to SY23-24 lottery cycles.
- What: Current School, Lottery School, and Match Result



Feedback collected from 1,600+ applicants




My School DC received notably fewer responses this year. Several respondents noted survey fatigue, and MSDC learned of several other concurrent education surveys open during our response window.




Overall applicant satisfaction in 2023



In open ended feedback, most comments were positive. Dissatisfaction with waitlist movement and frustration around Selective High School communication were common themes for lower ranked scores.








Respondents with IEPs and/or qualifying for at-risk funding.




At-Risk respondents continued to report slightly higher satisfaction than the average.



Proximity To Home Remains Key Decision Factor




1 in 3 respondents listed "close to where I live" as the key factors in both applying and enrolling, compared to 1 in 4 respondents this last year.



Satisfaction Continues to be highest for Ward 7 & 8



While Ward 2 satisfaction decreased for the second year in a row, with written responses indicating disappointment in both their match results & the process at large.




Parent Advisory Council Survey Results




Overall, PAC satisfaction increased in SY2023-24. The one exception was regarding effective PAC representation on the Common Lottery Board.


Participation in PAC met my expectations.

The parent perspective is effectively represented on the Common Lottery Board.




School Staff Generally Provided High Written Praise

Median was a 5 in each category



Rate your overall satisfaction with My School DC (1 = Not at all satisfied, 5 = Extremely Satisfied)

Across 'unsatisfied' feedback, comments were much more limited compared to last year.

Additionally, written feedback, while heard, may be difficult to implement:

- Requests for the Centralized Waitlist
 Management System to connect directly
 to and input data to LEA Student
 Information Systems (SIS).
- Requests for additional data shared with parents when a school will not generally offer seats or waitlist offers at a non-entry level grade.
